

Town of Union – Monthly Board Meeting Minutes
Wednesday, February 18, 2026

The Town of Union monthly board meeting was called to order by Chairman Jon Franke at 7:00 p.m. All stood for the pledge of allegiance.

Roll Call was taken with Chairman Jon Frank, Supervisor 1 Kurt Anderson, Supervisor 2 Nathan Toth, Treasurer Starr Janecek, and Clerk Fay Urban present. Others in attendance was Patrolman David Smith, Mary Bradford, and Lonnie Mueller from the Episcopo.

Review and Approve Minutes from Previous Meeting – Motion made by Toth and seconded by Anderson to approve the minutes for the January monthly meeting. All in favor, motion carried.

Treasurer's Report: The general checking balance is \$3,652.52 and the MMDA balance is \$538,911.04 as of Wednesday, February 18, 2026.

Clerks Report - The board reviewed the monthly bills. Motion by Anderson seconded by Toth to pay expenses as presented and transfer \$339,824.55 from the MMDA to the general checking account. All in favor, motion carried.

Mail: The town received notice that they are now in compliance with property tax values.

Old Business

UDC Inspector – Franke is in contact with Josh Baranczyk as a possible inspector once he finishes his certifications. Franke has not heard back from the state regarding this issue.

Salt Storage – The board discussed concrete block for the salt storage. Motion by Anderson and seconded by Toth purchase the concrete blocks from Croell Inc. in Hillsboro. All in favor, motion carried.

New Business

Go Over Gravel and Sealcoat Bid Request – Motion by Anderson and seconded by Toth to post an ad for road material bids due March 18, 2026 by 7:00 p.m. and approve them at the April board meeting. All in favor, motion carried.

Hillsboro Fire Department and Newly Purchased Used Fire Truck– Supervisor Toth reviewed the purchase of a used fire truck for Hillsboro Fire Department.

Patrolman's Report – Patrolman Smith review the road work they have done in the last month along with an equipment update. They would like to take out the old shelves in the shop and redo that area with a new sink and shelves.

Supervisor's Report – Toth went over the Hillsboro Fire Association meeting. He also attended the WI Towns Association (WTA) meeting 1/22/26. The county will be taking hazard material on May 30, 2026. The town owes the WTA \$50 annual fee.

Chairman's Report – Franke received one construction form. He clarified that the patrolman can cut brush along the roadway after there was a complaint. La Farge Lions Club gave the patrolman a plaque to recognize the work they do.
