

Town of Union – Monthly Board Meeting Minutes
Tuesday, January 20, 2026

The Town of Union monthly board meeting was called to order by Chairman Jon Franke at 7:00 p.m. All stood for the pledge of allegiance.

Roll Call was taken with Chairman Jon Frank, Supervisor 1 Kurt Anderson, Supervisor 2 Nathan Toth, Treasurer Starr Janecek, and Clerk Fay Urban present. Others in attendance was Patrolman David Smith, and Lonnie Mueller from the Episcope.

Review and Approve Minutes from Previous Meeting – Motion made by Toth and seconded by Anderson to approve the minutes for the December monthly meeting. All in favor, motion carried.

Treasurer's Report: The general checking balance is \$5,436.51 and the MMDA balance is \$510,482.60 as of Tuesday, January 20, 2026.

Clerks Report - The board reviewed the monthly bills. Motion by Toth and seconded by Anderson to pay expenses as presented and transfer \$250,044.67 from the MMDA to the general checking account. All in favor, motion carried.

Mail: The board signed a thank you card to Hillsboro East Church ALMS. La Farge Lions Club is hosting a thank you dinner for the patrolman at Rockton.

Old Business

Road Cost Share – The road cost share project for Stark Lane is looking good. The project can start in 2027 and must be completed by 2031.

Update on Well – The well was completed on 1/13/26. Waiting on final invoice.

UDC Inspector – As of 1/15/26 no proposal has come in for a UDC inspector. The town will default to the state for an inspector. Franke continues to work with the state on this issue.

New Business

Salt Storage – The salt pile need to be covered up with a trap. Cement blocks will be needed. The board needs prices on the blocks and it will be discussed at the next monthly meeting.

Patrolman's Report – Both trucks broke down on 12/31/25. 2015 truck was fixed at the town shop and the 2008 truck was towed to La Farge Truck Center for repairs. The patrolman have cut some trees along with plowing and sanding the roads.

Supervisor's Report – Toth will be attending the Hillsboro Fire Association meeting on Wednesday and the WTA meeting on Thursday.

Chairman's Report – Franke has been working with the state on a UDC inspector and Camp Cherith on new address signs.
